Borders Choice Homes Overcrowding Application Form

Priority for Overcrowding is awarded on two levels: Silver and Bronze.

You may qualify for **Bronze Priority** if your accommodation is **one bed space** short for your household.

- Children up to & including age 15 of the same sex can share a bedroom

You may qualify for **Silver Priority** if your accommodation is **one bedroom** short for your household.

- Children up to & including age 7 of different sexes can share a bedroom

All rooms in your existing accommodation which are bedrooms or could reasonably be used as such and all persons living there should be taken into account.

Housing staff may visit you at home to make an assessment if you apply for Overcrowding priority.
