Applicants serving in the Armed Forces can apply one year before their date of discharge and one year after. Gold priority will be awarded to applicants serving in the Armed Forces who:

- Are currently serving with one of the recognised Ministry of Defence Armed Forces, with less than one full year to discharge; and
- Has been discharged from the Armed Forces within the last year of applying for housing; and
- Has completed at least a 3-year fixed term contract or one full tour of duty
- Has been discharged due to injury within the past 12 months.

Gold priority will also be awarded to the surviving spouse/partner or a non-dependent child aged 16 or older of a deceased Forces Personnel, who served in the armed forces within the past 12 months.
